- Developed and managed the Internet Lab, a pioneering effort in gathering evidence related to fraud and deception on the Internet. Prepared needs assessment, supervised its implementation, and ensured that its evidence-gathering systems remained current. Maintained security according to Federal Information Security Management Act requirements; involved in assessments and in establishing security plan, policies, and procedures. Provided capabilities for eight regional offices to handle investigations through their own anonymous Internet connections.
- Participated as attorney and as technical advisor in enforcement matters related to the Internet and other technology-related matters, as well as cases in which electronic discovery issues were involved. Concentrated in security practices and breaches that might compromise consumer information, in fraudulent practices concerning Internet services, and in a variety of questions related to privacy, spam, and malware. Provided legal guidance and expert testimony in cases brought by the FTC, the U.S. Department of Justice, and the Australian Competition and Consumer Commission.
- Involved in development of policy related activities, including the Global E-Commerce Workshops and the London Action Plan on Spam. Prepared analyses of Internet-related issues such as proposed malware and spam legislation. Represented the FTC on interagency task forces on Internet governance and cybersecurity.
- Participated in FTC studies of Internet-related issues, including reports to Congress and an international analysis of consumer information provided on ecommerce websites. Had management roles in online privacy and ecommerce projects.
- Reviewed emerging technologies and methods, and advised staff on developments that might create new areas for inquiry. Provided instruction in technical issues related to the Internet and other technology matters, and in the use of evidence gathering systems and techniques in areas such as Internet fraud, spam, spyware, and ID theft. Prepared consumer and business information materials concerning systems-related topics, including wireless network setup and spam zombie protections.

- Managed development of the current FTC spam database, a full text system; the database is the only US government resource for raw spam messages submitted directly by the public, and has been used by other federal and state law enforcement agencies. Consulted concerning possible creation of similar systems with organizations involved in the Canadian Task Force on Spam and with the German ISP association.
- Managed BCP's Technology Support Group, a staff that provided assistance in the Internet Lab and in litigation support, Internet/Intranet development, and development and implementation of the Consumer Sentinel and ID Theft database systems. Interviewed and hired employees, and managed them using collaborative leadership. Mentored and coached, and prepared and provided job performance appraisals and periodic awards for exceptional service on particular projects.
- Established the Bureau of Consumer Protection's first dedicated litigation support group, which provided electronic discovery, document management, data seizure, data analysis, and courtroom technology support. Served on FTC-wide committee to review the broad range of agency requirements and find appropriate systems, software, and services to meet requisite needs.

- Managed and developed the first FTC electronic document management and trial presentation programs. Managed needs analysis, established criteria and budgets, evaluated proposals, and selected contractors. Supervised work of contractors and of FTC staff on individual matters. Collaborated on development of an agency-wide document and case management systems.
- Managed Bureau of Consumer Protection automated litigation support activities. Collected and analyzed electronic evidence gathered from a variety of platforms at companies that were the subject of FTC action. Managed the initial agency-wide efforts at adopting electronic document management and trial presentation technologies. Analyzed the broad range of FTC requirements, reviewed available software, systems, and services in light of FTC requirements and infrastructure, and made appropriate recommendations for purchase. Developed the FTC's first integrated litigation support document management system, procured trial equipment, and managed their implementation in FTC investigations and administrative and federal court proceedings.
- Consulted on investigations that concerned respondents in computer-related industries and prepared computer-related language for official documents.
- Collaborated in the development of Internet and X.400 systems at the FTC. Directed online posting of documents related to the 1996 Telemarketing Sales Rule rulemaking effort, the first federal administrative procedure with a significant online component. Served on agency-wide committees concerning local area network implementation, document management system development, Government Performance Results Act measures, and Information Technology Architecture efforts.
